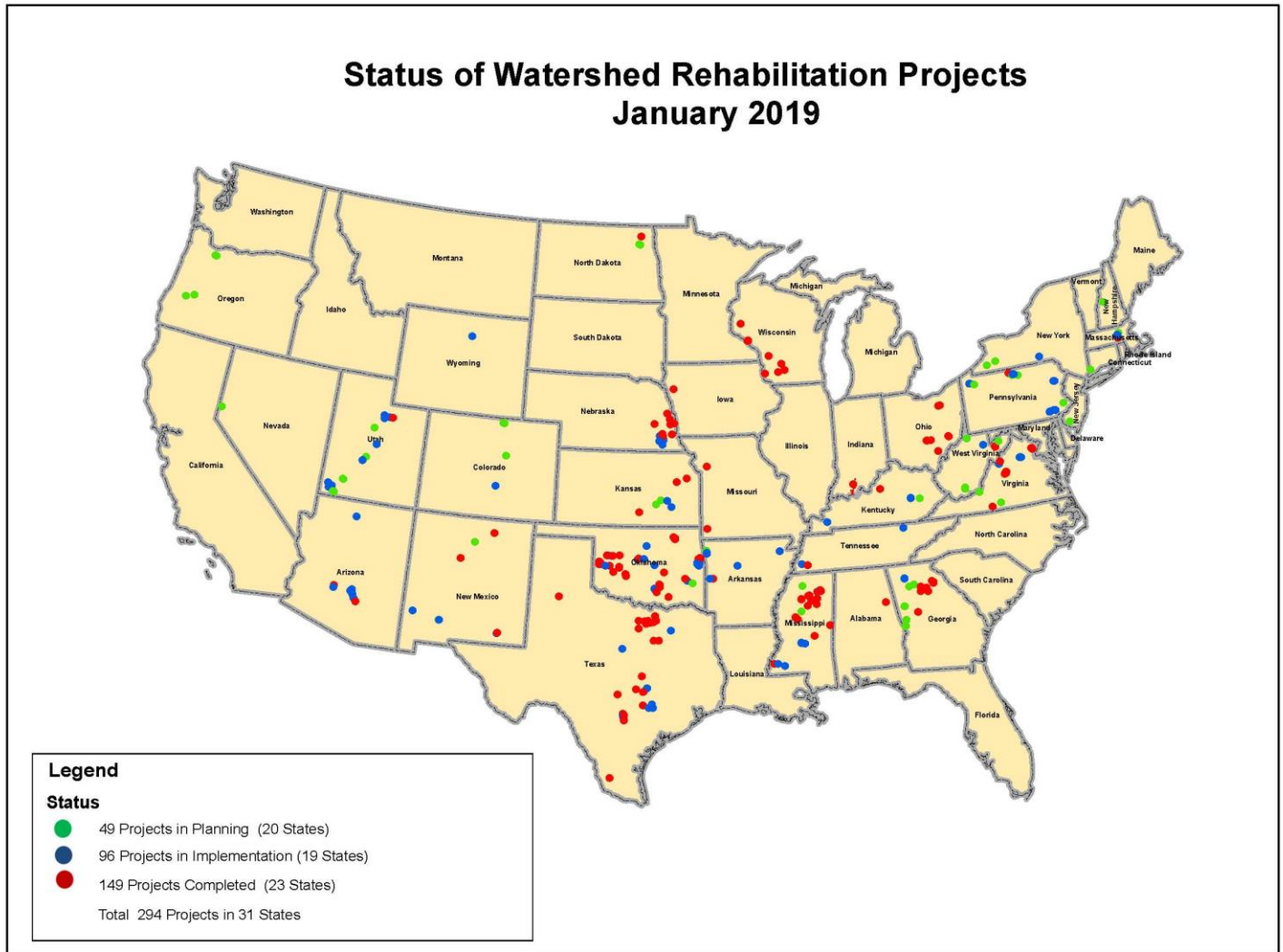


Watershed Rehabilitation Status January 2019 Report



2018 Activities

\$10 million in discretionary funding and \$55.2 million in mandatory was received for rehabilitation. The \$10 million in discretionary funding is a continuance of the typical annual investment in watershed rehabilitation, which recognizes the critical role of these watershed structures in flood management, water supply, erosion control, agricultural productivity, recreation and wildlife habitat. This funding helps to repair aging infrastructure, create jobs and commerce, and protects homes and families.

In 2015, project sponsors from 27 States submitted funding requests for 393 dams totaling more than \$502 million. This level of funding request demonstrates the need for dam rehabilitation assistance throughout the country. The funding requests far exceeded available funding. In 2018, projects ready for construction and design received priority for funding. Funding for construction was provided for 30 dams in 8 states and funding for designed was provided for 22 dams in 10 states.

In 2018, NRCS continued to provide funding for assessments of high-hazard dams based on the risk index. The agency utilized \$2,450,000 to complete assessments for 118 dams.
